OEA WELCOMES THE INTRODUCTION OF LEGISLATION TO DELAY THE USE OF HIGH-STAKES DECISIONS BASED ON STUDENT TEST

COLUMBUS — October 21, 2014 — The Ohio Education Association (OEA) today applauded the introduction of House Bill 642 by Representative Teresa Fedor, D-Toledo. The bill calls for a 3-year suspension of high-stakes decisions based on student test scores in measuring student growth and evaluating teacher performance.

"As Senator Peggy Lehner, the chair of the Senate Education Committee, has noted - 'we are over-testing our kids'," said OEA President Becky Higgins. "We urge state lawmakers to hit the pause button and determine which tests are actually needed and which are also appropriate for the grade level at which they're being administered."

OEA believes that with the use of the new Common Core standards in Ohio schools and the prospect of even more tests being conducted, it is important to take more time to make sure the implementation of these standards goes well.

"We've seen what has happened in other states where the hasty implementation of Common Core and the related testing has led to a backlash among parents, students and educators," continued OEA President Higgins. "We support Ohio's New Learning Standards, but we want to make sure Ohio gets it right. That's why we think taking the time to 'test the tests' would be a prudent course to follow."

Last spring, OEA members voted unanimously at their Representative Assembly to support the 3-year delay in the use of high-stakes decisions based on student test results. OEA is pleased that 18 co-sponsors have already signed on in support of Representative Fedor's bill.

"We recognize the need for a comprehensive assessment of student growth. But student assessments should not be over-

ly-dependent on the results of standardized tests, "said Higgins. "Students are spending too much time preparing for and

taking tests. There needs to be a more balanced approach to identifying the strengths and needs of students."

If you SKILLED or ACCOMPLISHED rating on PERFORMANCE last year, you do not have to go through the entire OTES cycle this year.

However, you do have to have an **unofficial observation**.

The observation is:

- · Unannounced
- · There is no 10-day window
- You have <u>one</u> opportunity to waive the observation

There will be a post-conference but nothing is reported to ODE and nothing goes in your file. You will only be asked to sign off that the observation happened.

OTES Update

Recap:

- ¶ At the beginning of the year, the District Evaluation Committee met to discuss and review the state's recent changes to the OTES process. At that time, we worked through many details and discussed the impact that OTES was having on our students, educators, and the district overall. There is no doubt that the OTES model has brought about a lot of change some good and some, maybe not-so-good. The goal has always been to utilize OTES to improve teaching and learning throughout the district in productive ways. By reflecting upon and changing those areas that were bringing the most frustration and concerns, I believe we have developed a more meaningful and united program. The attached document reviews the changes that have been made to our district's OTES model for this school year. Some of the highlights include:
 - o Shared Attribution for eligible educators
 - o Elimination of the SLO requirements
 - o Retirement and Leave option

SLOs:

¶ Even after the update meetings, there still remains a few questions concerning SLOs and what is required for this school year. Please allow me to reiterate the information - we are no longer participating in the SLO process. Therefore, if you are a SLO teacher - you do not need to turn in the SLO application; you do not need to administer a pretest and/or post-test to your students; and you do not need to measure ongoing student growth in your classrooms *for the purpose of your evaluation*. Please contact me directly if you have any questions about SLOs.

PD360 = Edivation:

- ¶ Last year, PD360 was the program we used to manage the documents associated with the OTES process. We will continue to use the program this year. *HOWEVER* the name has changed. PD360 is now called "Edivation". If you have forgotten how to access the program, here is some information that may help:

PROFESSIONAL DEVELOPMENT AND CHILD ABUSE TRAINING

Remember that this year's required in-service day (iPD) will be completed on an independent basis. This means that each of us is required to complete 6 hours of in-service training on our own time. The iPD program approach will provide our district's educators with the chance to participate in opportunities that specifically meet each individual's needs.

It just so happens that this year - is the year, the majority of us must retake 4 hours of Child Abuse Training. So, right off the bat - 4 of the 6 required hours are already planned for you.
